

The Declaration of Independence

(or Call for Dependence)

As Imagined by Christian Nationalists

WHEN in the Course of divinely-directed events, it becomes necessary for God's people to dissolve the earthly political bands which have connected them with an evil empire, and to assume among the ordained powers of the earth, the separate and equal station to which the laws of Nature and Commands of Jesus Christ entitle them, a decent respect to the correct religious opinions of mankind requires that they should declare the holy causes which inspire them to the separation.

We, the faithful, hold these truths to be scripturally sound, that all men (White, male, land-owning, evangelical Christians) are created exceptional and privileged by the Almighty, that they are endowed by the Father, Son and Holy Ghost with certain God-given Rights, that among these are Life (from conception to Eternity), Liberty (primarily for true Christians) and the pursuit of Happiness (that comes only from a personal relationship with Jesus through His one blessed Church)—That to secure these rights, Governments are instituted by God among Men, deriving their just powers from the grace of God.”

[**Actual:** “When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed,”]

The United States Constitution

As Imagined by Christian Nationalists

WE the devoted People of the Lord, residing in the promised land of the United States, in Order to form a more faithful and holy Union, establish divine Justice, insure spiritual Tranquility, provide for the common defence of morality, promote the general Welfare of His chosen People, and secure the eternal Blessings of Liberty to ourselves and our God-fearing Posterity, do pray for the Almighty to ordain and establish this Covenant for the United States of America, in the Name and for the Glory of our Lord and Savior Jesus Christ.

[**Actual:** “We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.”]

First Amendment: Congress shall make and enforce, under the guidance of Almighty God, laws respecting an establishment of the Christian religion, prohibiting the free exercise of any other false faith; strictly overseeing the freedom of speech and controlling the press; never restricting the right of the people to assemble for Sunday worship (regardless of public health directives), and our grievances should be given exceptional priority.

[**Actual:** “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble...”]

Article Six: A prayerful and theologically-sound religious Test shall be required as a Qualification to any Office or public Trust under the United States.

[**Actual:** “...no religious Test shall ever be required as a Qualification to any Office or public Trust under the United States.”]
